 - Two Years of Financial Statements (Balance Sheet and Profit and Loss Statement)
- **Process**
 - All completed credit applications need to be sent to credit@ontility.com
 - Credit decisions will be decided and communicated within 5-10 business days
 - All approved credit terms will be subject to annual credit review.
- **Credit Review Includes:**
 - Analysis of Dun & Bradstreet Report
 - Review of ONTILITY/BBB Industries, LLC purchasing history
 - Review of Financial Statements
